Dear Student,

I hope that you are enjoying your summer vacation. This letter is in reference to the procedures regarding registering to park in the Southern Regional High School student parking lot. All seniors and juniors with a valid New Jersey driver's license who are in good standing and have no obligations are eligible for a parking pass this year. Registered student parking will only be permitted on campus. Student parking is a privilege granted to our students. This privilege can be revoked by administration as part of consequences for inappropriate use of the lot or inappropriate behavior.

Students with outstanding obligations will not be issued a permit until their obligations are met. To find out if you have an outstanding obligation please call the 11/12 main office 597-9481 ext. 4264 or 4287.

Any senior or junior student who has a valid New Jersey driver's license and wishes to register to park must bring the following documents to the 11/12 main office during the week of August 16th - 19th between the hours of 8:00am -12:00pm:

1. A completed Southern Regional High School Parking Agreement.
2. Original copies of your driver's license, vehicle registration, and proof of insurance.
3. A photo copy of your driver's license, vehicle registration, and proof of insurance.
4. \$2.00 for your Southern Regional High School Student Parking Permit Sticker.

If you are unable to register to park during this time period, once school begins parking registration will be handled in the 11/12 main office prior to homeroom and after the school day. Please be sure that you have the necessary items listed above with you to register.

Guidelines will be given to you when you purchase your permit that outlines your responsibilities as a student and the rules regarding the governance of the student parking lot. We look forward to seeing you during the week of August 16th - 19th for registration.
