Postponement of Bid Due Date

Due to unforeseen circumstances the Bid Opening Due Date for the “**Track Rehabilitation and New Synthetic Turf Field at Southern Regional High School**” , originally scheduled for Wednesday, March 25, 2026 at 10:30am, has been postponed to the following new Bid Opening Due Date and Time:

Sealed bids will be received by Southern Regional School District at the Administration Building located at 105 Cedar Bridge Road, Manahawkin, New Jersey 08050 until **9:30 AM** local time, on **Tuesday, March 31, 2026**, and will be publicly opened and read immediately thereafter, at said place for the project titled “**Track Rehabilitation and New Synthetic Turf Field at Southern Regional High School**”

Bidders are requested to submit in accordance with N.J.S.A. 18A:18A-18(b)(2) one Lump Sum Bid for all the work and materials, single overall contract. Pursuant to N.J.S.A. 18A:18A-26, all bidders and their subcontractors shall possess the requisite DPMC trade classifications for the project, which include the following:

C008 or C009 with C060 and C061

Drawings, Specifications and other documents constituting the Contract Documents may be examined without charge at the office of Edwards Engineering Group, 92 East Main Street, Suite 204, Somerville, NJ 08876, Tel. (908) 231-9595, between the hours of 9:00 A.M. and 5:00 P.M, weekdays. The Contract Documents may be obtained on a USB Drive at the above office for the **NON-REFUNDABLE FEE of \$35.00 (Thirty-five Dollars)** made payable to “Edwards Engineering Group”. If shipping of Bid documents is required, then bidders may provide their direct shipping account number to Edwards Engineering or include an additional, non-refundable, **\$60.00 shipping & handling fee.**

Bids must be accompanied by a certified check, bank cashier's check, treasurer's check or Bid Bond in the form provided in the Contract Documents, with corporate surety satisfactory to the Owner, in an amount not less than 10% of the Base Bid (but in no case in excess of \$20,000.00, pursuant to N.J.S.A. 18A:18A-24), naming as payee or obligee, as applicable, **Southern Regional School District**, to be retained and applied by the undersigned as provided in Contract Documents in case bidder would default in executing the Contract or furnishing the required bonds and insurance certificates as required by Contract Documents. In addition, and pursuant to N.J.S.A. 18A:18A-25, each bid must be accompanied by a certificate from a surety company stating it will provide said bidder with a bond in such sum as required by the above referenced statute.

Prospective bidders are advised that this Project is one which will be subject and will be governed by provisions of New Jersey State Law governing (a) Prequalification and Classification of Bidders N.J.S.A. 18A:18A-26 et seq., (b) Prevailing Wage Rates N.J.S.A. 34:11-56.27, (c) Use of Domestic Materials, N.J.S.A. 18A:18A-20 including any amendments and supplements thereto, and (d) P.L. 1977, Chapter 33, (N.J.S.A. 52:25-24.2) listing corporate / partnership names and addresses for

individuals with a share of 10% or more.

“The Public Works Contractor Registration Act” became effective on April 11, 2000. A copy of the certificate must be included in the bid package for the bidder and any subcontractors.

Pursuant to N.J.S.A. 52:32-44 all business organizations that do business with a local contracting agency are required to be registered with the State and provide proof of their Registration with the New Jersey Department of Treasury, Division of Revenue before the contracting agency may enter into a contract with the business. All bidders shall adhere to the information as classified as “New Jersey Business Registration Requirements”.

Bidders must comply with the requirements of P.L. 1975, Chapter 127, N.J.A.C. 17:27 Law Against Discrimination.

No bids may be withdrawn for a period of sixty (60) days after the date set for opening of bids. In accordance with applicable law, the Southern Regional School District retains the right to waive irregularities in any bid, and/or or to reject any or all bids for failure to comply with the bid submission requirements/specifications, in accordance with applicable law.
