RULES AND REGULATIONS

- ⇒ Registration fee of \$25 per team is required at the time of registration. Forms, waivers, and cash or check (made out to "SRHSA") must be turned into the Main Offices of the 7/8, 9/10 or 11/12 by 2:15 on March 12th.
- ⇒ Must have at least 12 teams registered by March 12th for the event to take place. You will receive a text notification of confirmation or cancelation.
- ⇒ All teams must report to the 11/12 lobby to register at 5:30PM the date of the event.
- ⇒ All teams must have 3-5 players (5 maximum).
- ⇒ 1 person must be designated team captain.
- ⇒ Players must be wearing sneakers and shirts of the same color.
- ⇒ Team roster-all players must be on official roster to play.
- ⇒ No more than 1 Southern Basketball player per team.
- ⇒ Double Elimination-all teams will play at least twice.
- ⇒ Referee will start with a coin toss for possession of the ball.
- ⇒ Captains are responsible for keeping teams on time and abiding by rules. Captain can put subs in or out at any time by the back of the court/furthest from the basketball net.
- ⇒ Quarter Court Game. 3 versus 3.
- ⇒ There are no foul shots or time outs and the clock keeps running down from 8 minutes.
- ⇒ If any standard basketball rules are broken such as: double dribbling, stepping out of bounds, traveling, or fouls; the other team gets possession at the 3-point line at the top of the key and checks the ball to resume play.
- ⇒ If there is a tie score, alternate members will shoot free throws until one team misses.
- ⇒ Any arguing with the referees-you will receive a warning and second time, you will be ejected and your team will forfeit from the game. No refunds.
- ⇒ Any aggression, heckling, excessive profanity or flagrant fouls will result in the offending team being disqualified. No refunds.
- ⇒ Spectators cannot heckle or use profanity; this will result in expulsion from the building. No refunds.
- ⇒ Championship Game: Stop the clock in the final minute.
